## 申請須知

1. 豁免入場費優惠，專為學校、註冊慈善團體及註冊非牟利機構二十人或以上的參觀而設，不適用於其他團體參觀。而少於二十人的團體須繳付入場費。
2. 香港文化博物館開放時間為星期一、三至六上午十時至下午六時，星期日上午十時至下午七時，逢星期二(公眾假期除外)、農曆新年初一及初二休館。逢星期三免費入場(特別展覽除外)。
3. 申請人須於距離申請參觀日期最少兩星期前遞交申請表（只接受申請參觀日期起計三個月內之申請）。
4. 申請豁免入場費優惠的團體必須已根據社團條例或公司條例註冊立案，或已根據法例成立，或已註冊為認可慈善機構或公共性質的信託團體。在申請團體的章程或組織章程大綱及章程細則，或有關條例或信託契約中，必須明文規定，若團體解散，其成員不得分享利潤或資產。
5. 註冊慈善團體及註冊非牟利機構於遞交申請時，請附上有關之證明文件副本以證明其慈善性質或非牟利性質。**證書副本必須由機構負責人正式簽署，連同團體蓋印，以示真確。**
6. 填妥的申請表連同證明文件副本，可傳真(2180 8111)或郵寄回沙田文林路一號香港文化博物館，信封面請註明「申請豁免入場費」。
7. 如當天參觀團體眾多，本館將因應博物館各展廳可容納人數，按先到先得方法批准參觀申請。
8. 申請如獲批准，館方將致函覆實。申請人須於入場時出示該書面證明。**如於距離參觀日期兩星期前仍未獲回覆，請與本館職員聯絡（查詢電話：2180 8219）。**
9. 如申請資料有任何更改，申請人須於距離參觀日期至少一星期前通知館方作適當安排；如改動違反上述任何申請原則，或申請人未經許可擅自更改已批核的資料，館方有權隨時取消批准，並按實際情況索回入場費。
10. 本館發出批准書後，若申請人欲更改參觀日期、時間、人數或參觀安排，必須重新申請。
11. 關於各項申請，香港文化博物館擁有絕對決定權。申請能否獲得批准，須視乎申請人是否完全符合上述條件而定。如申請人不遵守以上規定或提供虛假的資料，館方有權取消批准及索回全部入場費。
12. 根據個人資料(私隱)條例第十八、二十二及附表一載列的第六原則，申請人有權要求查閱及更正表格內所提供的個人資料。申請人於表格內所提供之個人資料將會存檔於本館作記錄。申請人如欲查閱及更正本表格所收集的個人資料，請致電香港文化博物館與本館職員聯絡（電話：2180 8219）。
13. **惡劣天氣的博物館開放安排**
  - i. **8號或以上風球**：博物館將會關閉。倘若8號或以上風球除下時，距離博物館閉館時間不足兩小時，當日將不會開放。
  - ii. **黑色暴雨警告**：若博物館經已開放，則開放時間維持不變。若黑色暴雨警告在博物館開放前經已生效，博物館將不會開放，直至黑色暴雨警告除下。倘若除下時距離博物館閉館時間不足兩小時，當日將不會開放。

## Notes on Application

1. Application for waiver of admission charges is open to **groups of 20 or more** visitors from schools, registered charitable organizations and registered non-profit-making organizations only. Groups less than 20 are required to pay for the admission charges.
2. The opening hours of the museum is : 10am to 6pm (Monday, Wednesday to Saturday), 10am to 7pm (Sundays). **Closed on Tuesdays (except public holidays) and the first two days of the Lunar New Year. Free Admission on Wednesdays (excluding Special Exhibition).**
3. The applicant is required to submit the completed application form **at least 2 weeks in advance** of the intended date of visit (Application is accepted up to 3 months in advance).
4. The applicant for waiver of admission charges should be registered under the Societies Ordinance or incorporated under the Companies Ordinance or formed by statute or registered on the list of approved charitable institutions or trusts of a public character. Its Constitution or Memorandum and Articles of Association or Ordinance or Trust Deed should specifically provide that members do not take any share of the profits nor any share of the assets upon dissolution.
5. For registered charitable organization or registered non-profit-making organization, applicant should produce copies of supporting documents to identify the charitable nature or non-profit-making nature of the organization. **The copies should be certified true by an authorized officer together with the organization chop.**
6. Please fax (2180 8111) or return by mail (please mark "Application for Waiver of Admission Charges" on the envelope) the completed application form together with copies of supporting documents to the Hong Kong Heritage Museum, 1 Man Lam Road, Sha Tin.
7. If there is a large amount of group visitors within one day, application will be accepted on a first-come-first-served basis, according to the capacity of various galleries.
8. Successful application will be confirmed by letter and the applicant is required to produce the letter upon admission. If no reply is received from the Museum 2 weeks before the date of visit, please contact the Museum staff at **Tel no.: 2180 8219**.
9. Should there be any alterations regarding the visit, please notify the Museum **at least 1 week** before the date of visit for necessary arrangement. If the change violates the above criteria or the applicant changes the agreed information without prior permission of the Museum, the Museum reserves the right to refuse permission and recover the appropriate amount of admission charges.
10. New application is required for any change of the date and time of visit, the number of visitors and arrangement of the visit.
11. The Museum reserves the right to decide whether to approve an application. All applications are approved subject to the applicant's absolute compliance with the above-mentioned criteria. If the applicant fails to observe this condition or any information provided by the applicant is found to be untrue, the Museum reserves the right to withdraw the approval and recover the full amount of admission charges waived.
12. You have the right to request access to and to request the correction of personal data as stated in this form in accordance with Section 18, 22 and Principle 6 of Schedule 1 to the Personal Data (Privacy) Ordinance. The personal data you provide by means of this form will enter the record of the Museum. 13. **Museum Opening Hours during Inclement Weather**
  - i. **Typhoon signal No.8 or above:** The museum will close. If the signal is lowered less than 2 hours before the normal closing time, the museum will remain closed that day.
  - ii. **Black rainstorm warning:** If the warning is issued during normal opening hours, the museum will remain open. If the warning is issued before the museum opens, the museum will be closed until the warning is cancelled. If the warning is cancelled less than 2 hours before normal closing hours, the museum will remain closed that day.
