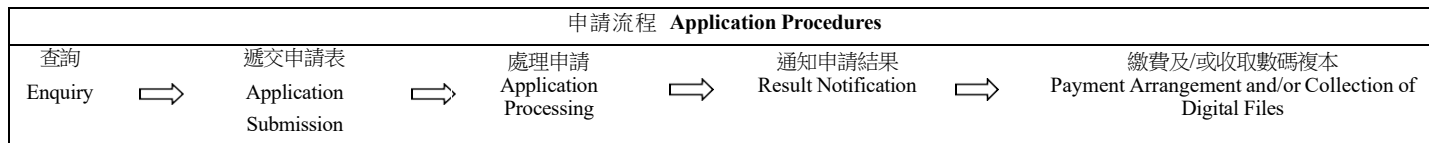

Application form can be submitted by post to Hong Kong Heritage Museum (Address: Resource Centre, 4/F, Hong Kong Heritage Museum, 1 Man Lam Road, Sha Tin, Hong Kong), by email (hkkm@lcsd.gov.hk) or in person.</p> <p>2. 部份館藏或未能提供高像素數碼複本，申請人宜先向本館職員查詢。查詢請致電：(+852) 2180 8188。 High resolution digital copies may not be available for certain collection items. Applicant is advised to consult the Museum staff prior to submitting application. For enquiries, please call (+852) 2180 8188.</p> <p>3. 由收到申請表及所需補充資料(如有)的日期起計，一般複製工作會於十四個工作天內完成；若要求複製的項目未有數碼檔案，或需較長時間處理。 Upon receipt of the application form and the supplementary information (if any), application for reproduction would normally be completed within 14 working days. It would take a longer processing time if digital file of the requested item is not available.</p> <p>4. 若申請人於付款後三個月內仍未提取已複製的項目，本館有權棄置該批項目，所有已支付的費用將不獲發還。 No refund of the fees already paid would be made if the reproduced items are not collected within three months from payment. The Museum reserves the rights to dispose of such reproduced items after the three months' period.</p> <p>5. 批准複製權只限使用<b>一次</b>，並只適用於申請表格內所述之用途。本館保留若干藏品項目的使用權及複印權。因此，申請人應先與本館職員磋商以確定是否可使用其所需項目。若其申請之用途抵觸本館形象和宗旨，本館亦有權拒絕其申請。 Permission for use of the reproduced item(s) is valid for only <b>one time</b> for usage as stated on the form. Applicants are advised to first make certain with the Museum staff if items required are available as the Museum reserves usage and reproduction rights on certain collection items. The Museum also reserves the rights to turn down applications in all stances where intended use of the items appears to be contrary to the image and interest of the Museum.</p> <p>6. 該等複製項目只可作聲明中列舉之用途。若申請人日後欲再次使用或以任何形式複製該等項目，必須再次申請並繳付相關費用；惟本館保留最後批核權。館藏圖像版權屬香港特別行政區政府所有。未經許可，嚴禁以任何形式翻印轉載。在未得本館及/或有關項目的版權持有人同意，不得擅自再次使用或複製任何項目，違者可能會被檢控。 The reproduced item(s) can only be used for the purpose as stated in the Declaration. Should the reproduced item(s) be required to be reused or reproduced in any formats in future, it is necessary to make a new application and is subject to relevant fees. The Museum reserves the rights on final approval. The copyright for the collection images belongs to the HKSAR Government. Reproduction without permission is strictly forbidden. Under no circumstances should any item(s) be reused or reproduced without the consent of the Museum and / or the copyright owner of the item(s). Unauthorized reproduction may be liable to prosecution.</p> <p>7. 不論以任何方式發表複製項目，引用博物館藏品項目時，須適當地註明「<b>香港文化博物館藏品</b>」，或於刊物、印刷品、視聽節目製作、網頁內適當地鳴謝香港文化博物館。申請人應按本館要求提供一份該項製作之完成品以作紀錄。 The publication of the items in any forms should be accompanied by the acknowledgement "<b>The Collection of Hong Kong Heritage Museum</b>", which should be printed adjacent to each reproduced item as practical unless the publication / printed material / audio-visual production / webpage contains a specific passage or note to acknowledge the Museum where appropriate. The applicant should provide a complimentary copy for record upon request by the Museum.</p> <p>8. 請與本館職員核實應繳費用。<b>本地申請人</b>請親身前往香港文化博物館，以劃線支票(抬頭請註明「香港特別行政區政府」)或現金繳費。<b>海外申請人</b>請以銀行本票或電匯繳付港幣淨額費用 (不包括銀行手續費)。職員確認收妥費用後，將電郵複製項目(如適用)予海外申請人。 Please check with the Museum staff responsible for the collection for the exact amount of payment. For <b>local applicants</b>, please pay by crossed cheques (made payable to "The Government of the HKSAR") or cash in person at the Hong Kong Heritage Museum.
